1. Copies
 - a. Original – to court where defendant is required to appear with the jailer's acknowledgment of delivery of accused to his custody.
 - b. First copy – to sheriff or jailer.
 - c. Second copy – to accused.
 - d. Third copy – to surety.
 - e. Additional copies as directed by local practice.
2. Data Element Nos. 1-12 are prepared by surety.
Data Element Nos. 13-14 are prepared by the clerk or judge.
Data Element Nos. 15-17 are prepared by person to whom the person was surrendered if capias was executed.
3. Attachments – none.
4. Preparation details – the Surety's Capias may be issued by the court where the accused is required to appear or the court of the jurisdiction where the accused was released on bond. See Va. Code § 19.2-149.

Data Elements

1. Court case number. (If case number not known, ask clerk.)
2. Name of court issuing this Capias.
3. Name of accused.
4. Name of surety.
5. Amount of bail bond secured by surety.
6. Name of court to which the accused was required to appear as stated on the bail bond, Conditions of Release and Recognizance.
7. Date and time of scheduled appearance.
8. Check this box if bonded in court indicated in Data Element No. 6, otherwise, complete Data Element No. 9.
9. Name of court if released on bail by an officer of a court in a jurisdiction other than the court named in Data Element No. 6, if applicable. If released by magistrate or district court, indicate the name of the appropriate district court.
10. Charge on which the accused was bonded as stated in bail bond.
11. Date on which surety signed the request.
12. Signature of surety.
