## **DATA ELEMENTS**

- 1. Insert court case number associated with offense listed in Data Element No. 9.
- 2. Name of court in which the accused is required to appear.
- 3. Name and residential address of the accused.
- 4. Information describing the accused (Race, Sex, Date of Birth, Height, Weight, Color Eyes, Color Hair and Social Security Number. Note: These boxes should be completed in whole or in part only as to those facts which are reasonably certain to be true.
- 5. Identify officer to whom summons is initially delivered for service and his bailiwick (e.g., "Sheriff of Fairfax County").
- 6. Date and time of hearing.
- 7. Jurisdiction in which the alleged offense occurred.
- 8. Date, on or about, which the alleged offense occurred.
- 9. Description of the alleged offense. Include statute (Code of Virginia section number) along with a verbal description of the offense, the Offense Tracking Number, and the applicable Virginia Crime Code reference (for administrative use only). If the summons is being issued for more than one offense, write "and charges below" on the last line of Data Element No. 9, before the words "as charged in an..." Then, complete Data Element No. 11.
- 10. Check appropriate block to indicate that the offense was charged in an indictment, presentment or information and insert date of such written document.
- 11. Complete requested information for each charge additional to the offense listed in Data Element No. 9. If more space is needed to list additional charges, see Data Element No. 12.
- 12. If applicable, check box and complete and attach circuit court form CC-1304, Charge Addendum.
- 13. Date of issuance of summons.
- 14. Signature of clerk if the clerk completed this form. If deputy clerk completed this form, print or type the clerk's name.
- 15. Signature of deputy clerk if deputy clerk completed this form.
- 16. Date and time of execution of summons.
- 17. Signature of serving officer.
- 18. Badge number of serving officer, employing agency and name of jurisdiction of arresting officer.
- 19. If summons served by deputy sheriff, insert name of sheriff.
